I. Tuition

1. Tuition Payment

A. Period: Jan. 9(Tue) 2024 ~ Jan. 12(Fri) 2024 09:00~16:00 [Regular Banking Hours]

B. How to Pay

1) Payment in Korea

- Designated Banks: Hana Bank, Woori Bank
- Using Virtual Payment Account: Transfer money to one of personal accounts(Hana Bank, Woori Bank) on the tuition bill (Making a deposit without a bankbook, internet banking, phone banking, CD/ATM, etc.)
 - ※ For those who are not transferring money from the banks listed above, they are responsible for paying any additional bank fees.

2) Payment out of Korea[To provide separate information]

- Alipay or Unionpay payments
 - Payments by Alipay or Unionpay using Hana Bank's unique account information for each student specified in the tuition payment notice
(refer to the attached document for details)
- Outside of Korea: Transfer money from abroad to CNU
 - ▶ Sender's name must be identical to the student's name on passport.
 - ▶ Account number will be Individually informed
 - ▶ Students who transfer money from abroad must fill in and send the form below to grad@cnu.ac.kr immediately after transferring money.

D. Notice about Payments

- 1) Successful applicant who does not pay tuition within the tuition payment period will be excluded from the admission list.
- 2) Tuition should be paid during regular banking hours(09:00–16:00)
- 3) Successful applicants must submit their tuition bill at the bank even if on a full scholarship. If not, admission will be automatically rescinded. **However, full scholarship recipients will be notified separately and we will replace your admission registration work only for those who request registration.**
- 4) After payment, please confirm if the payment has been successfully posted.
- 5) **Even if the tuition is paid, if there is a change in the final amount, additional payment occurs after admission.**

2. Notice of Payments

- A. An applicant who wants to renounce the enrollment at CNU after completing all of the registration procedures should submit a Registration Waiver Form and a Tuition Refund Request Form to the Office of International Affairs by Feb. 23(Fri) 2024.
- B. CNU will refund tuition to the renouncer according to the Article 6 clause 2 of the University Tuition Rules.

II. Additional Documents (if relevant)

1. Diploma/Graduation(Degree) Certificate

- A. Applicants who graduated from a university in Korea

Applicants who submitted a certificate of expected degree or completion must submit their official graduation certificate(diploma).

B. Applicants who graduated from a university outside of Korea

Applicants who did not submit an original graduation certificate either notarized by the embassy or by apostille must submit their original official graduation certificate(diploma) and transcript which have been notarized by the embassy or by apostille.

- ※ Applicants who graduated from an university in China must submit their Credentials Report or Online Verification Report of Higher Education Qualification Certificate after downloading from China Academic Degree & Graduate Education Development Center (<http://www.cdgd.edu.cn> or <http://www.chsi.com.cn>)

- Applicants who graduated from a university in Korea: until Mar. 7(Thu) 2024
- Applicants who graduated from a university outside of Korea: until Jan. 12(Fri) 2024[For VISA]
- ※ Enrollment will be canceled if successful applicants do not submit the above documents within designed period.

A. Period: from Mar. 4(Mon) 2024

B. Location: KEB Hana Bank of the First Student Hall(W-8)

C. Please bring your photo (3×4cm) and Identification card(passport or Alien Registration Card etc.)

2. How to Register: After reading the “Course Handbook(수강편람)” carefully and having a consultation with their department office, successful applicants must register for their courses through the website(<https://sugang.cnu.ac.kr/Flogin.do>)

- A. Successful applicants must register for their courses after a consultation with their department office within the above period, after paying the tuition.
- B. Login to the website(<http://cnuis.cnu.ac.kr/>) with your ID(application number) and password (birthday, YYMMDD total 6 digits), and register for courses. After finishing the course registration, confirm the registered course.
- C. Transfer student should be careful for the credit recognition when registering for course.

※ Restriction e.g.

- 1) Being admitted to Chungnam National University Master's degree course after dropping out of a Master's degree at another university in Korea
- 2) Being admitted to Chungnam National University Master's degree course after graduating from a Master's degree at another university in Korea

VI. Dormitory Guide

1. Expected Move-in date: Mar. 2(Sat) 2024 ~ Mar. 3(Sun) 2024, 09:00–15:00

※ Student must comply with the scheduled dates and check the notice(required documents e.g. TB test result, COVID-19 rapid antigen negative confirmation, uploading a photo etc.) on the dormitory web site(<http://dorm.cnu.ac.kr>) concerning details for living in the dormitory.

[COVID-19 related matters may change in the future]

※ After Mar. 3(Sun) 2024, students can move in only during weekdays from 09:00~18:00.

However, the moving in procedure is not permitted in lunchtime(12:00–13:00) and on weekends(including the national holidays).

※ Permission is not granted unless the submission documentation procedure stated in the announcement of precautions has been completed.

2. Duration of stay: Spring semester, 2024

※ An additional application is required to live in the dormitory for Summer vacation and the Fall semester(2024).

3. Dormitory Application and Announcement

A. Only students who applied for the dormitory during the admission application period are entitled to be selected for living in the dormitory.

※ Students who did not apply for the dormitory during the application period are not qualified.

B. Expected date of announcement for residence list: Jan. 23(Tue) 2024, 14:00

※ Result will be notified in the dormitory web site, and every new resident should be aware of “the Dormitory Notice for New Residents” which is located at the dormitory web site

- ※ TYPE 1 is the minimum type, and 10 meals on weekdays(breakfast or lunch, and dinner) are mandatory.
 - 1) Choosing breakfast or lunch is mandatory.
 - 2) Students who choose breakfast can buy separate meal tickets for lunch.
- ※ Students choose between TYPE 2~4 can use allocated meals for any meal(breakfast, lunch and dinner) on weekends.
- ※ Students can use the dormitory restaurant by purchasing additional meal tickets after using up all of your meals on weekends.
- ※ Except for the residents living in rooms for the married, and building 12 and 13, selecting at least one meal plan is mandatory. If residents want separate payment of meal, he or she should make inquiries to the restaurant(☎042-829-4026).

VII. Insurance

Information on the National Health Insurance Scheme of the Republic of Korea for Foreigners

If a foreigner resides in the Republic of Korea for six months or more, he or she will be compulsorily subscribed to the local subscriber scheme of the National Health Insurance starting from July 16, 2019, and he or she will receive the same insurance payment benefits as citizens of the Republic of Korea.

1. Those subject to enrollment

- Those who are not yet enrolled in the National Health Insurance of the Republic of Korea among those who have resided in Korea for six months or more.
- Marriage migrants (F-6) are subject to subscription as of entry date into the country (if your alien registration took place later than the date of entry, then from the date of registration)
- All foreigners except for those with A (diplomat), B (tourist), C (short-term), and G1 (miscellaneous) visas

2. Enrollment process: Processed uniformly by the National Health Insurance Service (NHIS) without any separate reporting procedure

- ※ If changing and reporting the place of residence at a registration government office, the applicant must report the detailed address precisely, such as the apartment or house number, so as not to incur complications from the mis-delivery of mail.
