2024 Global Korea Scholarship (GKS) Application Guidelines for Undergraduate Degrees (via Regional Universities)

1. PROGRAM OBJECTIVES

Global Korea Scholarship is designed to provide international students with opportunities to study at higher educational institutions in Korea in pursuit of academic degrees, which will enhance international education exchange and deepen mutual friendship between Korea and participating countries.

※ As Korean Government Scholarship Programs have been integrated and branded as Global Korea Scholarship in 2010, the name has been changed to GKS (Global Korea Scholarship).

2. Quota for University Track

Regional University Track (Bachelor's Degree)

※ Only those who hold citizenship of the countries below are eligible to apply.

3 . ELIGIBILITY

Prospective applicants must meet all of the following conditions.

1) Nationality

- All applicants must hold citizenship of NIIED designated countries that are invited to take part in the GKS program.

- All applicants and their parents must NOT hold Korean citizenship. If an applicant or his/her parent(s) hold dual citizenship (one who have Korean citizenship and citizenship of another country), he/she is NOT eligible to apply.

※ Applicants and their parent(s) may hold different citizenship. Applicant's parent(s) may hold a citizenship of none GKS participating countries.

※ Applicants and their parents who had previously held Korean citizenship must submit documentation that proves their renunciation of Korean citizenship issued by Korean Government.

2) Level of Education

- Applicants who graduated (or are expected to graduate) from a high school can apply for a Bachelor's degree program or an Associate degree program.

- Applicants who graduated (or are expected to graduate) from an associate degree program can only apply for a Bachelor's degree program.

※ Applicants who are expected to graduate by February 28th, 2024 must first submit a certificate of expected graduation. The official degree certificate (or diploma) and final academic transcript must be submitted to GKS Center, NIIED by February 28th, 2024 at the latest. If a scholar fails to submit their official degree certificate (or diploma) and final academic transcript by the deadline, his/her acceptance to the scholarship will be canceled. Any scholarship (e.g., airfare, settlement allowance) that was provided to the scholar will need to be returned.

3) Grades

- All applicants must have maintained a **Cumulative Grade Point Average** (CGPA) equivalent to or higher than any ONE of the following from their respective schools*

- Score percentile should be 80% or above on a 100-point scale or be ranked within the top 20% within one's class
- CGPA : 2.64/4.0, 2.80/4.3, 2.91/4.5, 3.23/5.0

* Applicants for Bachelor's Degree: High School or Educational Institute of Associate Degree

- If an applicant holds a transcript that does not include information on CGPA or is unable to convert his or her grades into any one of the GPA scales (4.0, 4.3, 4.5, 5.0, or 100 point scale), then the applicant must submit additional documents officially issued by their school describing the school's grading system.
- (Applicants who are expected to graduate) Calculate CGPA at the time of application.

4) Age

- Must be under 25 years of age (born after March 1, 1999)

5) Health

- All applicants must be in good health, both mentally and physically, to study in Korea for the full duration of the program.
- If an applicant is found to be in one of the following conditions, the applicant will be disqualified in the final round of selection:
 - An applicant tests positive on drug tests.
 - An applicant who has a serious illness that prevents him or her to study abroad for a long duration of time.

※ All applicants must submit "Form 6. Personal Medical Assessment" at the time of application. All applicants who pass the 2nd round of selection must receive comprehensive medical checkup and submit an Official Medical Examination issued by a medical doctor or a licensed hospital. After arriving in Korea, all GKS scholars will be subject to a medical examination administered by NIIED. If a GKS scholar is found to have a serious illness from the medical examination after arriving in Korea, he or she will be disqualified from their GKS scholarship.

6) Restriction

- A person who has graduated (or is expected to graduate) from a Korean high school (including international schools) or who has graduated (or is expected to graduate) from a Korean associate degree program is NOT eligible to apply
 - ※ A person who graduated from an online curriculum arranged by a Korean school/university cannot apply
 - ※ A person who is currently in their final year at a Korean high school or Korean university cannot apply
- A person who had previously received a scholarship for a degree program from the Korean government is NOT eligible to apply
 - A previous (or current) GKS scholar who are currently in, have completed, or graduated from a GKS associate degree program
 - A previous GKS scholar whose scholarship was cancelled after their enrollment

※ A previous GKS scholar who has received scholarships from GKS Non-degree program for exchange students CAN apply

※ (Exception) Former GKS scholar whose scholarship was forfeited due to a scholar's failure to achieve TOPIK level 3 or above after completing Korean language program may be deemed eligible to re-apply if a scholar submits a valid TOPIK certificate of level 5 or above

- Former GKS degree program applicants who has withdrawn from the program or was disqualified from the scholarship after being selected as GKS scholars in recent three years cannot apply
- Duplicate Applicants unavailable
 - University track applicants must apply to only one program among UIC, Regional University, and Associate Degree programs. Each applicant must apply to ONE university and single department

※ If an applicant applied to more than one track/program/university, his or her application will be disregarded in the evaluation and the scholarship will be cancelled if found afterward

7) Preference

- Overseas Koreans
- Applicants from low-income families or underprivileged background
- Applicants who submit a high score of English proficiency test (TOEFL, TOEIC, IELTS)
- Applicants who applied for a natural science and engineering department in a regional university
- (Relevant to associate degree applicants) Winner of a national level competition on technical skills

4. AVAILABLE UNIVERSITIES AND FIELDS OF STUDY

- The Regional University Track applicants can only apply for departments that are listed under the field.
- Please keep in mind that Korean is the core language to be used in every Korean university

5. Required Documents

- 1 set of the original documents below

1) Document to Complete (Required)

- ① Application Form (Form 1)
- ② Personal Statement (Form 2)
- ③ Study Plan (Form 3)
- ④ Single letter of Recommendation (Form 4)
- ⑤ GKS Applicant Agreement (Form 5)
- ⑥ Personal Medical Assessment (Form 6)

2) Certificates (Required)

- ⑦ Proof of Citizenship
: Official certificate issued by the government such as Birth certificate or/and Family register that can prove ①family relationship and ②citizenship
- ⑧ Certificate of graduation
: Official high school graduation certificate (or Diploma) or Associate degree certificate (or Diploma) that indicates year/month of graduation
: Application who are expected to graduate must submit an official certificate of expected graduation that indicates the month/date of graduation

• A Simple certificate of enrollment is NOT accepted as a certificate of expected graduation

: If an applicant who applied before their graduation fails to submit their official certificate of graduation by February 28, 2024, his or her acceptance for the scholarship will be canceled and must return to their home country on their own expense. Any scholarship (e.g., airfare, settlement allowance) that was provided to the scholar will need to be returned

⑨ High School Grade Transcript

: Official transcript issued by a high school or an educational institute
: If an applicant holds a transcript with a grading system that are not 4.0, 4.3, 4.5, 5.0 or 100 point scale, it must be converted into one of the

4.0, 4.3, 4.5, 5.0 or 100 point scale with supporting documents officially issued by the school/institute

· If an applicant converts his/her grades through a converting tool such as scholaro.com, the converted grades must be acknowledge by the school/institute with an officially issued letter

· If the grade is not submitted in one of the above scales, applicant's transcript cannot be evaluated
: As long as a transcript has a CGPA of the entire school years, it will be accepted even though it does not indicate GPAs per semester/year.

· In this case, applicant do not need to provide GPA per semester/year and only need to provide a CGPA on the application form

※ Documents which verifies Academic Record (Apostille Certificates or certification by the embassy for documents of official graduation certificate and transcript. Applicants from the countries that joined the convention must only submit Apostille certificates, and embassy confirmation will not be considered valid)

- ⑩ Proof of Overseas Korean
: Prove with supporting documents such as family register or birth certificate
- ⑪ Proof of Age
: If none of the document indicate applicant's date of birth, submit additional document officially issued by the government that includes date of birth information.
- ⑫ Proof of Korean Citizenship Renunciation Document (Optional)
: Required for relevant applicant
- ⑬ Certificate of valid TOPIK score (Optional)
- ⑭ Certificate of valid English Proficiency Test (Optional)
- ⑮ Proof of Korean War Veteran's Descendant
- ⑯ Applicant's Passport Copy (Submit if necessary)
- ⑰ Copy of awards and other certificate (Submit if necessary)

3) Instructions on 'Documents to complete'

- All applicant documents must be written either in Korean or English.
- Information such as applicant's name, date of birth, name of applying university/department, etc. should have no errors since they will be used in official documents (e.g., invitation letter, certificate of admission, visa application form, flight ticket).
- Applicants must submit a letter of recommendation from a single recommender, who can provide thorough assessment on the applicant's academic abilities. The recommendation letter must be sealed in an envelope and be submitted to the Embassy or University that conducts the first round of selection.
- (Form #1. Application Form) University track applicant must write only ONE university and ONE department.

4) Instructions on 'Certificates'

- University track applicants should submit only ONE consular-authenticated (or apostilled) document.
- All certificates must be authenticated by a consulate or apostilled before submission.

Certificates that are written either in Korean or English

☞ Submit with an authentication by a Consulate or with an apostille.

Certificates that are written in languages other than Korean or English

☞ Both certified translation and (a copy of) original certificate that is written in an original language must be authenticated by a consulate or be apostilled.

※ Certificates that are only notarized will NOT be accepted. Consular authentication or apostille is required for all certificates. Certificates written in their original language must be submitted together with their certified translation.

- For the applicants whose certificate (e.g., diploma) is issued only once and cannot be reissued in the future, we strongly recommend those applicants to get a consular authentication or apostille on a certified true copy of the certificate and keep the original certificate. Please bear in mind that all documents submitted to NIIED will NOT be returned to the applicants in any case.

5) NOTES

- ① 1 set of the original documents should be put in a single envelope.
Recommendation letters should be sealed by the recommenders and submitted with the seals unbroken.
- ② Original documents should be submitted. However, if copies are submitted, copies must be authenticated by the issuing institution, confirming that they are the same with the originals.
- ③ The applicant's name on the application form MUST be identical to the applicant's passport name.
- ④ If there is any inconsistency in the applicant's name or birth date on submitted documents, further evidential document must be submitted as verification.
- ⑤ Any applicant, who submits a provisional graduation certificate at the time of applying, must submit his or her official graduation certificate of high school upon arrival in Korea, no later than February 28th, 2023.
- ⑥ The application documents must be arranged in the same order as written on the "Checklist" in the FORM 1. Each document may be stapled. However, DO NOT staple the entire application documents altogether, or put each

document in a separate folder.

- ⑦ Application form and all other materials should be filled out either in Korean or in English. Any document issued in languages other than Korean or English MUST include official notarized translations. Notarized documents should be arranged in front of originals.
- ⑧ All documents submitted must be A4 sized. If the document is smaller, attach it to A4 sized paper; if bigger, fold it to make it A4 sized.
- ⑨ The high school grade transcript must contain a description of the school's grading system. In case the transcript does not have information on the applicant's rank or percentile score, an applicant must submit an additional official certificate issued by the high school, confirming that the applicant's academic achievement meets the requirement written on 5-(5) above.
- ⑩ All documents must be numbered and labeled on the top right corner. (Example. Graduation Certificate of High School)
- ⑪ Mailing address should be stated in full including the postal-code.
- ⑫ Submitted documents will not be returned to the applicant. The applicants are advised to make their own copies of all application documents.
- ⑬ Incomplete or incorrect documents will result in the disqualification of an applicant.

6. Application Deadline

- Applicants must submit all the required documents to the address below until October 20th, 2023.

※ Applicants must follow the NIIED's regulations throughout the application procedure.

- Korean Proficiency Grants is given only to GKS scholars in the degree program who hold valid TOPIK level 5 or 6.
- Entry flight ticket will NOT be provided to newly selected scholars who have resided in Korea at the time of final announcement of 2024 GKS Undergraduate Degree Scholars.
- On applicants' initial arrival to Korea, any domestic travel fees within a GKS scholar's home country and any international travel insurance for the trip to Korea is NOT covered.

※ Additional expenses for departure (e.g., PCR test for COVID-19, self-quarantine before departure) will not be covered by NIIED

- Entry flight ticket or any visa application support will NOT be provided to scholars who enter Korea from a country other than the scholar's own country of citizenship.

- If a GKS scholar withdraws from the scholarship within the first 3 months after entering Korea (or after enrolled at their Korean language institute or university), one MUST return the full scholarship amount that he or she has received after being selected as GKS scholar. This will include the airfare from one's home country to Korea, settlement allowance, monthly allowance, language training fees, medical insurance fees, etc.

9. Other Important Information

: Prior to arrival, all scholars should study about Korea, Korean language and culture. In particular, we advise grantees learn as much Korean as possible since most classes at a Korean university are taught in Korean. 2. 선발 인원: 15 명 (아래 국가의 국적을 소지한 자만 지원 가능)

- ※ 지원자 또는 부모가 한국 국적을 가졌던 경우, 한국 국적 포기를 증명하는 한국정부 발행 서류 제출 시 지원 가능

2) 학력

- 고등학교 졸업(예정)자 학사 과정 지원 가능
- 전문학사 졸업(예정)자는 학사 과정만 지원 가능
- ※ 졸업예정자(2023. 12. 31. 기준)는 지원 시 졸업예정증명서를 제출하고, 합격한 경우 2023년 12월 31일까지 최종 성적증명서와 졸업증명서를 제출해야 하며, 미제출 시 합격 취소

3) 성적

- 직전학교* 모든 학년 종합 성적이 다음 조건 중 하나를 충족하는 자
 - 백분율 환산 점수 80% 이상 또는 석차 상위 20% 이내
 - C.G.P.A 2.64/4.0, 2.80/4.3, 2.91/4.5, 3.23/5.0 이상
- * 직전 학교: 전문학사 지원자는 고등학교, 학사 지원자는 고등학교 또는 전문대학
- ※ C.G.P.A. : Cumulative Grade Point Average, 종합 평균 평점
- 성적표에 종합 평균 평점에 대한 정보가 기재되어 있지 않거나, 성적을 C.G.P.A. 또는 백분율로 환산하기 어려운 경우 성적에 대한 최종학교의 공식적인 설명 자료 추가 제출
- 졸업예정자 종합 평균 평점은 이수한 모든 학년 성적으로 산출

4) 연령

- 만 25 세 미만 (1999.3.1. 이후 출생)

5) 건강

- 한국에서 장기간 유학이 가능할 정도로 심신이 건강한 자
- 다음의 경우 최종 선발에서 제외되거나 합격 취소
 - 마약복용 판정을 받은 자
 - 장기간 수학이 어렵다고 판단되는 질병을 가진 자
- ※ 지원 시 자가건강체크리스트 (Personal Medical Assessment)를 제출하고, 입국 후 본원 주관 건강검진 시 심각한 질병 확인될 경우 합격 취소

6) 지원제한

- 한국 내 고등학교(외국인학교 포함) 또는 전문대학을 졸업(예정)한 사람
- ※ 한국 소재 학교의 온라인 과정을 졸업한 사람은 지원 불가
- ※ 한국 소재 학교의 마지막 학년에 재학 중인 사람은 지원 불가

- 한국정부로부터 학위과정 장학금을 수혜 받은 사람
- GKS 전문학사 과정을 재학, 수료 또는 졸업한 사람
- GKS 학위과정 장학생으로 입학 후 '자격상실'된 사람
- ※ 국립국제교육원 우수교환학생 프로그램 참여자는 지원 가능
- ※(예외) 한국어 연수 후 TOPIK 3급 이상 미취득으로 자격상실 된 경우에 한해 5급 취득 시 재지원 가능

- 최근 3년 간 GKS 학위과정 장학생으로 최종 합격 후 입학 전 포기했거나 합격이 취소된 사람
- 중복지원 불가
 - 대학전형 내 UIC, 지방대, 전문학사 과정 중 한 개 과정만 지원 가능하며, 한 개 대학, 한 개 학과만 지원 가능
 - ※ 중복 지원한 경우 심사에서 제외되며 심사 후 발견될 경우 합격 취소
